1. Packages

a. Business Starter:

The Package includes a subscription to Google Workspace Business Starter at a rate of RM11.85 per user per month for the first 20 users. This offer is applicable only to new customers who are not covered by the Cloud Framework Agreement ("CFA").

b. Enterprise Starter:

The Package includes a subscription to Google Workspace Enterprise Starter at a starting rate of RM27.5 per user per month (RM330/12) for 3 years. This pricing is applicable to customers covered by the CFA with a minimum number of 180 users.

2. Subscription and Renewal

- The Package subscription is valid for the agreed term, as specified during the signup process.
- The subscription will automatically renew for successive terms equal to the initial term unless either party provides written notice of termination at least 30 days before the end of the current term.
- If the number of users exceeds the limits specified in the Package, additional charges may apply, and the subscription fee will be adjusted accordingly.

3. Termination

- Either party may terminate this Agreement for any reason by providing written notice to the other party.
- In the event of termination, your access to the Package and any related services will be discontinued immediately.

4. Amendments

The Company reserves the right to modify or amend these terms and conditions at any time. Notice
of any changes will be provided to you in writing.

5. Payment Terms:

- Payment for the Package subscription is due in full and in the currency specified at the time of purchase.
- The Company reserves the right to suspend or terminate access to the Package in the event of nonpayment or late payment.

6. Usage Rights:

• The Package grants you a non-exclusive, non-transferable license to use the provided services and features in accordance with the terms and conditions.

7. Data Security and Privacy:

- The Company is committed to protecting your data and maintaining the confidentiality of any personal or sensitive information collected during the use of the Package.
- The Company will comply with applicable data protection laws and regulations in the collection, processing, and storage of your data.
